APPENDIX 1

Search Context:

Gioia Stokovac and Alisa Almas requested a rapid literature search with respect to “Early Childhood, Later Life Outcomes”, with particular focus on early experiences and Indigenous high school completion. This search involved scoping for literature on indigenous children/youth and high school completion. The focus was narrowed to Canada. Select international articles were included which seemed relevant to the topic, along with papers broadly touching on high school completion or indigenous childhood context. Additional searches can be carried out by Gioia or Alisa as needed using the results here as a foundation for the topic. There may be an interest in exploring more specific early childhood factors and potential relevance to later life outcomes such as graduation.

The search focused on publications from the last 10 years (2010-2020) but older articles are included. The focus was on Canada, however no geographic limits were set so some international papers are included. Because of the breadth of this topic, it is not exhaustive. The requestors may wish to continue building the search by manual bibliographic review of key papers and citation chaining.

Project overview:

A goal is to review the literature related to early childhood, indigenous context, and graduation. There are many aspects to this and this search is an initial look at the literature. Target audiences will include academics, practitioners, professionals, and policy/decision makers at all levels who are involved in public policy and similar areas, looking beyond clinical, acute and emergent care settings.
